

**FIXED CARRIER LICENCE
TELECOMMUNICATIONS ORDINANCE (Chapter 106)**

PCCW Global (HK) Limited (“Company”)

Name of Tariff:

Price for International Satellite Private Lease Circuit Services (“Service”)

Description of Service:

The Service is an international private dedicated lease circuit service implemented using satellite communications technology. The Service provides a point-to-point clear channel connection between the customer’s premises in Hong Kong and overseas. In Hong Kong, the customer utilizes the Company’s Hong Kong teleport facility plus local digital data line connection. At overseas destination(s), the customer is required to maintain a Very Small Aperture Terminal (VSAT) antenna on their rooftop for reception. As such, an end-to-end private lease circuit will be established for the customer’s use.

1. The above price is based on using the Company's Hong Kong Teleport to a remote rooftop VSAT station. It includes Hong Kong local data circuit, the satellite capacity, and equipment required to establish the circuit.
2. In those overseas countries where rooftop VSAT solution is prohibited, the Company may provide local teleport service plus local data circuit access to customer premises at major cities.
3. For any service requirement with circuit speed above 10Mbps, the Company will serve on case-by-case basis.
4. The above offers are for a minimum commitment period of 24 months.
5. Overseas VSAT license fee is not included in the above prices. The Company may optionally provide the support in overseas VSAT license based on customer requirements, and with additional charges.
6. Tax is not included.
7. The above Service offers shall be subject to feasibility study, including regulatory feasibility at overseas countries, and capacity availability at time of order.
8. The Service under relevant service plan(s) is subject to applicable terms and conditions (as amended from time to time) set out in the service agreement(s) as agreed between the Company and the Customer.
