Description of Tariff:

The tariff for the Services (which includes but not limited to International Direct Dialing (“**IDD**”) Service) is set out in Annex A.

1 March 2014

Revision to the tariff published in Tariff published in Tariff No. U0025-002-Feb2013-R on 1 February 2013 in respect of service provisioning and call rates to certain countries.

International Call Services (“Services”)

The Services offered by HKT enable a person to make and/or receive a telephone call from Hong Kong to overseas or vice versa (as the case may be) by using a device from a fixed line, mobile handset (via mobile voice or smartphone*), computer device or other equipment via applicable interconnection facility(ies) (which include but not limited to International Direct Dialing (“IDD”) Service, accessing the Services via a calling card, call-back service (which may involve linking up two IDD calls originated from Hong Kong), international call forwarding service and international toll free service).
