Revision to the tariff published in Tariff No. F050-0029 on 24 April 2009 in respect of service provisioning and charges of the Service.

HKT EasyWatch Commercial Service (“Service”)

The Service is a broadband Internet access service for commercial customers dedicated for connection to IP Camera(s) only. The Service includes HKT EasyWatch Plus and PCCW EasyWatch Enterprise Solution.

Under PCCW EasyWatch Plus, a commercial customer is provided with broadband Internet access under an agreed upload/download specification dedicated for connecting with designated IP Camera(s) owned by the customer and/or provided by HKT installed at the customer’s premises where HKT also provides video recording storage for the customer at HKT’s designated facilities.

PCCW EasyWatch Enterprise Solution is a legacy service provided by HKT to customers subscribed to the service prior to June 2014 which is a video data service for commercial customers to capture video images by IP camera(s) supplied by HKT installed at their own premise. Captured video can be viewed by its owner via the Internet with an appropriate device (e.g. a PC) and a software web browser all at his/her own costs and expenses. In addition, captured video can be recorded. Customers can access the Service through the following accessing means:

- PC with Microsoft Internet Explorer Web Browser
- Mobile Phone via video call or wap access[^]
- Fixed line phone via video call[#]

[^] For mobile access to the Service (e.g. 3G video call and 2.5G/3G WAP data streaming), the Service only supports 3G phones with video call capability for video call access and 2.5/3G phones with 3GPP-compliant player, such as Real Player One for wap access. Customer shall be responsible for the prevailing charges applicable to service providers for using the Service through 3G Video call and data access on various platforms

[#] The cost of viewing the Service through fixed line phone via video call is subject to the prevailing charges of various service providers.
