- Note 4: International SMS only applicable to users at Canada, England, China (eye Multimedia Service / eye2 Communication Package can't receive the International SMS from China pre-paid phone card), Australia, Taiwan, Singapore, Macau and Philippines.
- Note 5: The installation of parallel extension ("PE") is only applicable to areas within the PE service coverage. A maximum of 4 sockets per telephone line and subject to on-site conditions.
