## 予受惠者的 15GB 4G 本地流動數據卡 一細節:

## Details of the 15GB 4G local mobile data card to the beneficiaries:

- 1. 香港電訊為受惠者提供的 15GB 4G 本地流動數據卡使用期為兩個月,當中包括無限本地 通話分鐘及 Wi-Fi。
  - HKT will provide a 15GB 4G local mobile data card for the beneficiaries which can be used for two months. Services include unlimited local voice call service and Wi-Fi.
- 2. 15GB 4G 本地流動數據卡最高下載速度為 42Mbps,超過首 15GB 用量的流動數據網絡規格將會被降至上限 128kbps。
  - The maximum download speed of the 15GB 4G local mobile data card is 42Mbps. After the first 15GB, the subsequent data transmission speed will be capped at 128kbps.
- 3. 此數據卡不包含國際長途電話及漫遊服務,使用者如使用該等服務則需自行支付費用。 IDD and roaming services are not included; users need to subscribe and pay for these services.
- 4. 視乎活動的反應,每位受惠者或可另獲額外 15GB 的充值額,其使用期為兩個月。
  Depending on the response of the activity, each beneficiary may receive an additional 15GB local mobile data, which is valid for two months.
- 5. 受惠社福機構/學校需為受惠者作登記,包括姓名及聯絡資料。
  The participating NGOs/schools are required to register for the beneficiary, including their names and contact information.
- 6. 15GB 4G 本地流動數據卡,不可出售,或作其他圖利用途,一經發現即作廢。
  The 15GB 4G local mobile data cards are prohibited from re-selling or used for other profitable purposes, otherwise the data cards will be void.
