POLL RESULTS AT THE ANNUAL GENERAL MEETING HELD ON MAY 9, 2013

At the annual general meeting of unitholders of the HKT Trust and shareholders of HKT Limited (the “**Company**”), as convened by HKT Management Limited (the “**Trustee-Manager**”, in its capacity as the trustee-manager of the HKT Trust) and the Company, held on a combined basis as a single meeting characterized as the annual general meeting (the “**AGM**”) of holders of share stapled units (the “**Share Stapled Units**”) on May 9, 2013, all the proposed resolutions as set out in the notice of AGM dated March 27, 2013 (the “**AGM Notice**”) were voted on by poll.

Computershare Hong Kong Investor Services Limited, the registrar appointed for the Share Stapled Units, acted as the scrutineers for the poll at the AGM.

All the ordinary resolutions as set out in the AGM Notice were duly passed by way of poll at the AGM held on May 9, 2013 and the poll results are as follows:
