## Election of Means of Receipt and Language of Corporate Communications

- (1) to read all future Corporate Communications published on the Company's website at [www.hkt.com](http://www.hkt.com) ("**Website Version**") in place of receiving printed copies, and to receive a notification ("**Notification**") of the publication of the Corporate Communications on the Company's website; or
- (2) to receive the printed English version of all future Corporate Communications only; or
- (3) to receive the printed Chinese version of all future Corporate Communications only; or
- (4) to receive both the printed English and Chinese versions of all future Corporate Communications.

You have the right at any time to change your elected means of receipt and choice of language by providing reasonable prior notice in writing to the Company and/or the Trustee-Manager c/o the Share Stapled Units Registrar or by sending an e-mail to [hkt@computershare.com.hk](mailto:hkt@computershare.com.hk). If you have difficulty in receiving or gaining access to the Website Version of the Corporate Communications, the Company and the Trustee-Manager will, upon your request in writing or by e-mail, promptly send the printed versions of the Corporate Communications to you free of charge.
